GUIDELINES & ROADMAP FOR THE 2023 GHANA FOOTBALL ASSOCIATION ELECTIONS

Pursuant to Article 54 of the GFA Statutes, 2019 and the provisions of the GFA Regulations on Elections, 2019, the Elections Committee of the GFA set out the Guidelines and Roadmap below for the 2023 Ghana Football Associations' elections as follows:

1. ELECTIVE POSITIONS

Elections shall be conducted for the following positions:

- a. Ghana Football Association (GFA) President and Executive Council
- b. Regional Football Association (RFA) Chairperson and Executive Council
- c. District Football Association (DFA) Chairperson and Executive Council

2. NOMINATIONS

- i. Nominations for the various positions shall open and close as per the roadmap below
- ii. Nomination forms can be obtained from the GFA Secretariat or downloaded from the GFA website (www.ghanafa.org).
- iii. A copy of the completed nomination forms submitted shall be endorsed by the GFA and returned to the candidate.

3. NOMINATION FEES

- c. Regional Football Association (RFA) Chairperson GH¢10.000.00
- d. 2 RFA Slots in GFA Executive Council GH¢ 5,000.00
- e. Regional Football Association (RFA) Executive Council GH¢ 2,000.00
- f. District Football Association (DFA) Chairperson GH¢ 1.000.00
- a. District Football Association (DFA) Executive Council GH¢500.00
- h. Female Aspirant for each of the above position 50% of Fee Above

The Pay-in Slip or Transaction ID Number shall be submitted together with or written on the completed nomination forms.

4. **VOTING PROCEDURE**

The voting procedure shall conform to Part IV of the GFA Regulations on Elections, 2019.

5. VENUE FOR ELECTIONS

The venue for the Elections shall be communicated per the elections Roadmap.

6. COMPLIANCE WITH GFA STATUTES & GFA REGULATIONS ON ELECTIONS

The Elections will be held in full compliance with the provisions of the GFA Statutes 2019 and the GFA Regulations on Elections, 2019.
